

Privacy Statement

This statement summarizes what personally identifiable information we may collect, and how we might use this information.

Information Collection

Spintech Holdings Inc. will collect personally identifiable information (such as name, title, company name, address, telephone number, or e-mail address) that is voluntarily provided through our website, e-mail correspondence, trade shows, seminars or other Spintech Holdings Inc. sponsored events.
